 ORDINANCE OF THE TOWNSHIP OF NORTH HANOVER AMENDING THE
 REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF NORTH HANOVER,
 CHAPTER 19 "FEES"

BE IT ORDAINED by the Township Committee of the Township of North Hanover, County of Burlington, State of New Jersey, amending and supplementing Chapter 19 of the Revised General Ordinances of the Township of North Hanover as follows:

Chapter XIX, Schedule of Fees, new Section 19-3:030.4 entitled, "Snow Removal Rates," specifically Removal by township of Ice and Snow from private streets as outlined in Chapter 3, Section 120.4 and Section 110:

 Any part of an hour will be charged full hourly rate

BE IT FURTHER ORDAINED that the Public Works Foreman or person in charge of Public Works Department will determine equipment necessary and manpower needed; and

BE IT FURTHER ORDAINED that a determination shall be made by the police department, emergency management, or public official that action shall be taken by Public Works on private property, with Public Works documenting hours, material, costs; and

BE IT FURTHER ORDAINED that all ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

BE IT FURTHER ORDAINED that this ordinance shall take effect immediately following final adoption and publication as required by law.
