

**ORDINANCE 2022-06  
COUNTY OF BURLINGTON  
TOWNSHIP OF NORTH HANOVER**

**AN ORDINANCE OF THE TOWNSHIP OF NORTH HANOVER, COUNTY OF BURLINGTON, STATE OF NEW JERSEY APPROPRIATING \$150,000.00 FROM THE CAPITAL IMPROVEMENT FUND TO PROVIDE FOR VARIOUS CAPITAL IMPROVEMENTS**

**BE IT ORDAINED** by the Township Committee of the Township of North Hanover, in the County of Burlington, State of New Jersey, as follows:

**SECTION 1.** \$150,000.00 is hereby appropriated from the Capital Improvement Fund of the Township of North Hanover, in the County of Burlington, New Jersey (the “Township”) to provide for various capital improvements and accessory equipment therefor and incidental thereto as follows:

Police Vehicle Camera’s	\$ 10,000.00
Drainage Imp. and Engineering	\$ 40,000.00
Computer’s and related Equipment	\$ 45,000.00
Municipal Building Flooring and related equipment	\$ 20,000.00
Municipal Building Doors	\$ 20,000.00
Harley Rake	\$ 15,000.00

**SECTION 2.** Said acquisitions are lawful capital improvements of the Township having a period of usefulness of at least five (5) years. Said improvements and acquisitions shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefited.

**SECTION 3.** This ordinance shall take effect upon final passage and publication according to law.
