AN ORDINANCE OF THE TOWNSHIP OF NORTH HANOVER, COUNTY OF BURLINGTON, STATE OF NEW JERSEY AMENDING CHAPTER 7, SECTION 7-080 "SPEED LIMITS" OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF NORTH HANOVER BY CHANGING SPEED LIMIT FOR A SECTION OF ELLISDALE-CROSSWICKS ROAD AND ESTABLISHING SPEED LIMITS FOR SEGMENTS OF MEANY ROAD

NOW, THEREFORE, be it ordained by the Township Committee of the Township of North Hanover, in the County of Burlington, New Jersey that Section 7-080, Schedule VII of the Revised General Ordinances of the Township of North Hanover is hereby amended as follows (deletions have strikethrough; additions are bolded and underlined):
