**AN ORDINANCE OF THE TOWNSHIP OF NORTH HANOVER, COUNTY OF BURLINGTON,  
STATE OF NEW JERSEY AMENDING CHAPTER 7, SECTION 7-080 “SPEED LIMITS” OF THE  
REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF NORTH HANOVER BY CHANGING  
SPEED LIMIT FOR A SECTION OF ELLISDALE-CROSSWICKS ROAD AND ESTABLISHING  
SPEED LIMITS FOR SEGMENTS OF MEANY ROAD**

**NOW, THEREFORE**, be it ordained by the Township Committee of the Township of North Hanover, in the County of Burlington, New Jersey that Section 7-080, Schedule VII of the Revised General Ordinances of the Township of North Hanover is hereby amended as follows (deletions have strikethrough; additions are bolded and underlined):

Section 1.     **SECTION 7-080, SPEED LIMITS**

Section 2. In the event that any portion of this ordinance is determined to be invalid, such determination shall not affect the remaining portions of ordinance, which are hereby declared to be severable.

Section 3. All ordinance or parts thereof, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.

Section 4. This ordinance shall take effect immediately after final passage and publication according to law.
