### M. MISCELLANEOUS FEES\*

Contracts signed at least twenty-four (24) hours in advance of assignment:

Officers hourly rate \$50.00 per hour \$65.00 per hour Monday-Friday
\$97.50 per hour Saturday/Sunday

## \$97.50 per hour Holiday

Contracts signed less than twenty-four (24) hours in advance of assignment: Officers hourly rate \$97.50 per hour Monday-Sunday and Holiday

Administrative costs \$\frac{\\$10.00 \text{ per hour}}{\$20.00 \text{ per vehicle}}\$\$ \$\frac{\\$15.00 \text{ per hour}}{\$150.00 \text{ per vehicle}}\$\$

- 1. If job exceeds eight (8) hours in a day, the police officer(s) shall receive time and one half for time worked after eight (8) hours
- 2. If a private employer or entity cancels a job at least two (2) hours prior to the scheduled start time, it will not be responsible for any rate for officer time for said cancellation
- 3. If a private employer or entity cancels a job with less than two (2) hours notice, it will be charged for four (4) hours as follows:
  - a. \$260.00 per police officer
  - b. \$60.00 administrative fee; and
  - c. \$150.00 per police vehicle per day.

**NOW THEREFORE BE IT RESOLVED**, by the Township Committee of the Township of North Hanover, County of Burlington, that the change in the fees for Off-duty Police Officers and related expenses are hereby adopted; and

- The Township shall order the necessary supplies utilizing, if desired, the contracts the District has negotiated with various vendors.
- The District shall pay the Township, upon receipt of the appropriate and fully executed voucher, the amount of \$10,800.00 subject to Board of Education approval.

## RESOLUTION 2015-78 TOWNSHIP OF NORTH HANOVER COUNTY OF BURLINGTON

## RESOLUTION AUTHORIZING THE FILING OF DECLARATORY JUDGMENT COMPLAINT WITH THE SUPERIOR COURT AS AUTHORIZED BY THE SUPREME COURT IN IN RE ADOPTION OF N.J.A.C.5:96 and 5:97 BY THE NEW JERSEY COUNCIL ON AFFORDABLE HOUSING

**WHEREAS,** on December 17, 2008, the Township of North Hanover and its Land Use Board adopted and endorsed a third round Housing Element and Fair Share Plan (collectively "Compliance Plan") based upon the revised third round "growth share" rules and methodologies that were adopted by the New Jersey Council on Affordable Housing ("COAH") as codified at N.J.A.C. 5:96 and 5:97; and

**WHEREAS**, the revised "growth share" rules were under challenge in the Appellate Division at the time that the Township adopted the Compliance Plan; and

**WHEREAS,** the Township petitioned COAH for substantive certification on December 30, 2008 and COAH granted substantive certification on May 14, 2009 notwithstanding the pending challenges to the growth share rules; and

**WHEREAS**, the revised growth share rules upon which the Township's Compliance Plan was based were ultimately invalidated by the Appellate Division on October 8, 2010; and

**WHEREAS,** the Appellate Division decision invalidating the rules was upheld by the Supreme Court on September 26, 2013 in <u>In re Adoption of N.J.A.C. 5:96 & 5:97 by the Council on Affordable Housing.</u> 215 N.J. 578 (2013); and

**WHERAS,** the Supreme Court remanded to COAH with specific instructions as to new rulemaking and the calculation of new third round fair share numbers for all municipalities in the State; and

**WHERAS,** COAH failed to abide by the Supreme Court's rulemaking directives which resulted in judgement enforcement proceedings before the Supreme Court; and

**WHEREAS**, the Supreme Court issued a decision and Order on March 10, 2015 which divested COAH of further rulemaking and administrative review authority and determined that the Court must once again resume its roles as the forum of first resort in ensuring municipal affordable housing compliance; and

WHERAS, the Supreme Court crafted a procedure for municipalities that participated in the COAH review process to retain repose and immunity against builder's remedy litigation and exclusionary zoning challenge while trying to address their third round fair share obligation when it is established by the Court by authorizing municipalities to file declaratory judgment proceedings with the Court by July 8, 2015 pursuant to N.J.S.A. 52:27D-313(a) and by committing to prepare and submit a new third round Compliance Plan once the Court resolves the third round rules and calculates third round fair share obligations; and

**WHERAS**, the Township wishes to retain its repose and immunity against builder's remedy litigations and exclusionary zoning challenges and hereby authorizes its attorney to file declaratory judgment proceedings with the Court on or before July 8, 2015.

**NOW THEREFORE, BE IT RESOLVED,** by the Township Committee of the Township of North Hanover that it's affordable housing attorney be and is hereby directed to file declaratory judgment proceedings with the Court pursuant to N.J.S.A. 52: 27D-313(a) on or before July 8, 2015.
